## Commitment to achieving net zero

Streets Heaver Computer Systems Limited is committed to achieving net zero emissions by 2050 at the latest.

## Emission Reduction Targets

To continue our progress towards achieving net zero, we have set the target of reducing our Scope 1, Scope 2, and Scope 3 by **22%** by 2025 on a 2021 baseline.

## Carbon Reduction Projects

The following environmental management measures have been implemented or are in the process of being introduced since the 2021 baseline. These measures will be in effect moving forward. It is worth noting that the baseline is calculated during the COVID-19 pandemic with very low office occupancy when the country was not in full lockdown.

- ✓ Continue to reduce energy consumption by introducing policies around energy use and educating employees.
- ✓ Build awareness amongst our workforce of the impact of their decisions on our journey to net zero.
- ✓ Promote greener transport through cycle and electric car schemes such as Bike to Work and Octopus.
- ✓ All Company Cars to be zero emission vehicles.
- ✓ Actively quantify emissions from commuting and working from home to reduce scope 3 through employee engagement and a rolling employee survey.
- ✓ Ensure key suppliers are committed to reducing their carbon footprint and become net zero by 2050.
- ✓ Reduce business travel by air, rail, and road through effective measurement and a sustainable travel policy.
- ✓ Commit to purchasing greener infrastructure and equipment.
- ✓ Actively quantify emissions from commuting and working from home.
- ✓ Allowing employees to take 1 day per year to help with a charitable or environmental cause.
